# **General informations**

# Intended use

ER4H qualifies as a medical device as it provides information to doctors and nurses that is used to make decisions for diagnostic or therapeutic purposes for patients in the emergency room.

While most features facilitate memorization, archiving, communication, simple search or administrative tasks, ER4H supports clinical decisions through

- View relevant patient data, such as vital sign values and out-of-range visual indicators
- calculation of the emergency/severity index (Triage)
- Configuration and calculation of clinical scores

# Indications and user personnel

*ER4H - FIRSTAID WEB* is a system that involves different figures within a hospital system:

- **Doctors:** are supported in the management of the emergency medical record, through an overview of the patient's data (summary), updated in real time.
- **Nurses:** operate on the system carrying out all the functions of completing medical activities such as: patient acceptance, assessment of the degree of severity in access, collection of p. vital signs, recording of therapy administration.
- **Medical consultants:** manage all consultancy reporting activities if requested by the ED doctor both for patients who benefit from general consultancy (ER patients) and for patients referred to specialist paths (see for example: FastTrack path)

**Administrative staff:** through ER4H FirstAid Web, based on the policies defined by the Customer, manages the work list control activities, information to relatives as well as the generation of reporting files, statistical analyses, etc.

All personnel qualified for the use of ER4H must carry out the training activities required by the manufacturer.

The term "qualified personnel" includes all people capable of operating and intervening on the *FIRSTAID WEB software* in a safe and effective manner, with knowledge of the language in which the manual is supplied, signs and commands present in the manual and/or on the software same.

ER4H FirstAid Web is not authorized to be used to support direct management of dispensing robots without human supervision prior to dispensing to the patient.

The use of ER4H FirstAid Web to support the direct management of the prescription of respiratory and aesthetic machines is not authorized.
